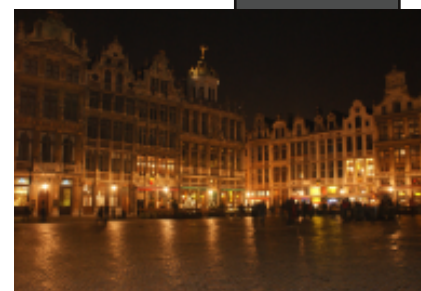

### **Public and Non-Profit Management SIG Outcomes @ EURAM 2015**

The Warsaw 2015 Conference proved to be a highly successful event for all those involved in the Public and Non-Profit Management SIG:

108 authors and 47 paper presentations, over the course of 14 scheduled sessions.

Sessions were organized along four core Tracks:

**-Public and Non-Profit Management General Track**, coordinated by D. Cepiku, A. Bonomi Savignon and Reto Steiner.

**-Management Research in Healthcare Organizations**, coordinated by R. Hernandez

**-Governance of Public and Non-Profit Organizations**, coordinated by F. Monteduro and A. Hinna

**-Accountability, Sustainability and Ethics in Public and Non-Profit Organizations**, coordinated by F. Giordano.

A plenary session was held in which results from a Strategy survey launched last year were presented and discussed. One initiative which has been deemed highly valuable by SIG members is the promotion of events taking place in-between annual conferences, such as Winter workshops.

After a very successful winter seminar in Leipzig on State-owned enterprises, organized by prof. Papenfuss, a forthcoming workshop has been announced for December 2015 at the University of Western Cape in Cape Town, on the theme of "Is Local Always Better? Strengths and Limitations of Local Governance for Service Delivery". The CfP for this event is attached.

The Call for Topics for next year's EURAM conference in Paris was also described and discussed; coherently with what emerged in the Survey, interdisciplinary and cross-SIG topics and DWGs were encouraged and envisioned.

The SIG is also planning on renewing its governance and has announced a Call for Candidatures for new officers and chairs. To participate, a CV and a motivational letter should be sent to [euram.public.management.sig@gmail.com](mailto:euram.public.management.sig@gmail.com) by October 31st.

The **Managing Sport SIG** has received four topic propositions for a special track and one symposium proposition.

We were very proud to say that the FBR SIG has grown as a group and it recognizes its own identity within the European community.

We had two pre-activities, one on the topic of "Research Methodology in the Field of Family Business: exploring new tools" and the other on "State-of-the-art of the field of family business". In the first one, we had Lorraine Uhlener as keynote speaker; in the second one, we had Bart Debicki as keynote speaker. They both gave us an outstanding lectures. We had also an open discussion with all the participants and we notice that a lot of people in the audience were from other SIGs of Euram.

We had several parallel sessions, and the presented papers were summed up in the general assembly by the session chairs. In the general plenary, we awarded the best paper (by Susanne Beck and Reinhard Prugl) and the best reviewer (Jana Hauck) with a plaque sponsored by Witten University.

Finally, we had a very nice dinner in a Polish restaurant with 40 participants of the SIG. After that, we had a wine tasting with 5 different European wines and a complete explanation (with slides) by the owner of the winebar about the origin, the land, the taste and the fitting menu for each wine.

### **\*\*\*\*OB SIG Best Paper AWARD 2015\*\*\*\***

Winner of the OB SIG BEST PAPER Award (sponsored by EMERALD'S 'Evidence-based HRM')

Stefano Ferriani (ENEA) & Edoardo Mollona (University of Bologna). CONTINUITY OF ASSOCIATION, FREEDOM TO REWIRE AND THE DARK SIDE OF RECIPROCITY. MICRO-PROCESSES OF EFFORT RECIPROCATION AND PARTNER SELECTION AND MACRO-PROCESSES OF INTEGRATION AND SEGREGATION IN INTRA-ORGANIZATIONAL NETWORKS OF EXCHANGE

The winning paper was chosen for its innovative approach applying computational simulation methods to a classic OB problem (association and rewiring). We believe this paper presents something unusual and partially unexpected results. Thus, it reflects the openness to non-mainstream approaches, diversity and quality present in the community of OB SIG scholars at EURAM.

**President's Award for Excellence in Teaching and Learning**

Dr Brian Harney was the recipient of the Dublin City University President's Award for Excellence in Teaching and Learning 2015. Based on nominations from students and colleagues, 23 staff were shortlisted with Brian selected by a panel as the overall winner in the academic category. Student citations noted:

**CLUSTERING: Annual Workshop on Industrial Clusters and Districts**

The Faculty of Economics (University of Valencia-Spain) hosted the eleventh edition of this two-day Workshop (27-28 of May).

Two new activities were included: two Symposia and one Doctoral Workshop with a prize of 500€. More than 70 scholars from 10 nationalities presented 22 papers. The Symposium with managers dealt with the binomial cluster-performance and the University-Firm linkage in industries such as automobile, clothing, toys and ceramic tiles. The Symposium with reputed scholars focused on current research challenges and the evolution of notions.
